The Sales Complex will be open for the arrival of horses from **9am Sunday 28th January**. Please do not arrive before this time as you may not be permitted to enter the complex without prior arrangement.

VENDOR NOTICE

Vendors are always requested to have a **representative present at their stable(s)** to show horse(s) to prospective purchasers. Also, in the interest of Health & Safety Vendors must leave headcollars on all sold lots.

SPECIAL NOTICE: For Insurance reasons all Lots must be led with a bit in their mouth and by a person aged 16 or over.

SALES REQUIREMENTS

Please ensure you have all the following documentation before arriving at the Complex:

YEARLINGS

Vendors are reminded that, for the February Sale, yearling requirements will mirror foal requirements in relation to Influenza Vaccinations. For this Sale, as it is so early in the calendar, there is **NO** mandatory requirement for Flu Vaccinations.

- Passport
- **Animal Health Certificate (dated withing 15 days of Sale)** – each cert **MUST** be uploaded via your **online account** **PRIOR** to arrival at the Sales Complex.

MARES

Mares in foal:

- Passport ***MUST** be registered as a Broodmare with Weatherbys Ireland.
- **Animal Health Certificate (dated withing 15 days of Sale)** – each cert **MUST** be uploaded via your **online account**.
- Covering Certificate
- Pregnancy Certificate (**dated within 21 days of the Sale**)
- C.E.M. & EVA (**dated within 30 days of the Sale**)
- EHV Vaccinations – All pregnant mares are required to have been vaccinated against EHV in the **5th 7th & 9th month** of pregnancy and the details recorded in the mare's passport.
***Any mare that does not have relevant EHV vaccinations will be isolated and sold in absentia.**

Potential Broodmares

- Passport
- **Animal Health Certificate (dated withing 15 days of Sale)** – each cert **MUST** be uploaded via your **online account**.
- Fillies Examination Certificate (**dated within 14 days of the Sale**)
- C.E.M. & EVA (**dated within 30 days of the Sale**)

Barren Broodmares:

- Passport
- **Animal Health Certificate (dated withing 15 days of Sale)** – each cert **MUST** be uploaded via your **online account**.
- C.E.M. & EVA (**dated within 30 days of the Sale**)

All Heath Certificates **MUST** be uploaded via your **online account** before arrival on site and all mare paperwork **MUST** to be emailed to Michelle Daly at **mdaly@tattersalls.ie** by **Tuesday 23rd January**.
