

## **GENERAL INFORMATION**

The November National Hunt Sale will commence at 10.00am on Sunday 10<sup>th</sup> November, 2024.

The Sales Complex will be open for the arrival of **all Sunday and Monday Lots** from **8am Friday 8<sup>th</sup> November**. Please do not arrive before this time as you may not be permitted to enter the complex without prior arrangement. Unfortunately, early arrivals cannot be facilitated on site for this sale, and Vendors are respectfully asked to strictly adhere to the times of arrival. Please see below arrival times.

- Second standing foals selling on Tuesday - arrival from **7am on Monday 11<sup>th</sup>**.
- Second standing foals, selling on Wednesday, & Mares - arrival from **7am on Tuesday 12<sup>th</sup>**.

## **Departures**

To facilitate second standings, lots concerned will be moved 1 hour after being offered for Sale. Vendors are reminded that for horses not removed from the complex within 48 hours after being through the ring, an overnight charge will apply per horse, per night.

## **SALE DOCUMENTATION CHECKLIST**

Please ensure you have all the following documentation before arriving at the Complex:

### **Yearlings**

- Passport
- **Animal Health Certificate (15 days)** – each cert **MUST** be uploaded via your [online account](#) **PRIOR** to arrival at the Sales Complex.
- **Flu Vaccinations** - The Vaccination History is checked from the passport when lodged on site. There is no requirement to send in a copy prior to arrival. Minimum requirement for all Yearlings is the primary course (consisting of 2 injections). Where vaccinations are found not to be up to date, a fee will be applied to the vendor's account.

#### **Influenza Vaccination Intervals:**

- Initial vaccination.
- Second vaccination between **21 and 60 days** after the first.
- Third vaccination between **120 and 180 days** after the second.
- Booster vaccination administered within each succeeding **six months**.
- In accordance with Conditions of Sale 10.9 yearlings are returnable when they can be heard to make a characteristic abnormal inspiratory sound when actively exercised and which are found to have Laryngeal Hemiplegia (Recurrent Laryngeal Neuropathy) following endoscopic examination. Yearlings should be capable of being lunged left and right.

### **Foals**

- Passport
- **Animal Health Certificate (15 days)** – each cert **MUST** be uploaded via your [online account](#) **PRIOR** to arrival at the Sales Complex.

**\*\*Influenza Vaccinations are currently NOT a Sales Requirement for foals\*\***

## **Mares**

### ***Mares in foal:***

- Passport \***MUST** be registered as a Broodmare with Weatherbys Ireland.
  - **Animal Health Certificate (15days)** – each cert **MUST** be uploaded via your [online account](#).
  - Covering Certificate
  - Pregnancy Certificate (**dated within 21 days of the Sale**)
  - C.E.M. & EVA (**dated within 30 days of the Sale**)
  - EHV Vaccinations – All pregnant mares are required to have been vaccinated against EHV in the **5<sup>th</sup> 7<sup>th</sup> & 9<sup>th</sup> month** of pregnancy and the details recorded in the mare's passport.
- \*Any mare that does not have relevant EHV vaccinations will not be permitted entry to the Complex.**

### ***Potential Broodmares***

- Passport
- **Animal Health Certificate (15 days)** – each cert **MUST** be uploaded via your [online account](#).
- Fillies Examination Certificate (**dated within 14 days of the Sale**)
- C.E.M. & EVA (**dated within 30 days of the Sale**)

### ***Barren Broodmares:***

- Passport
- **Animal Health Certificate (15 days)** – each cert **MUST** be uploaded via your [online account](#).
- C.E.M. & EVA (**dated within 30 days of the Sale**)
