- Early arrivals <u>cannot be facilitated</u> on site for this sale, and Vendors are respectfully asked to strictly adhere to the times of arrival.

Special Notice: For insurance reasons all lots must be lead with a bit in their mouth and by a person aged 16 and over.

SALE REQUIREMENTS

YEARLINGS

- **Passport** *In accordance with Article 66 of Commission Delegated Regulation *DAFM
- Animal Health Certificate MUST be uploaded via your <u>online account</u> PRIOR to arrival at the Sales Complex (dated within 15 days of the Sale).
- Up to date Flu Vaccinations

The vaccinations against Equine Influenza are required to be administered as follows: The primary vaccination (consisting of 2 injections) must be given not less than **21 days** and not more than **60 days** apart. Where vaccinations are found not to be up to date, a fee will be applied to the vendor's account.

 In accordance with Conditions of Sale 10.9 yearlings are returnable when they can be heard to make a characteristic abnormal inspiratory sound when actively exercised' and which are found to have Laryngeal Hemiplegia (Recurrent Laryngeal Neuropathy) post endoscopic examination. Yearlings should be capable of being lunged left and right.

FOALS

- **Passport***In accordance with Article 66 of Commission Delegated Regulation *DAFM
- Animal Health Certificate MUST be uploaded via your <u>online account</u> PRIOR to arrival at the Sales Complex (dated within 15 days of the Sale).

MARES

Vendors of mares are requested to have all relevant documentation (as outlined below) lodged with the Bloodstock office before Friday 8th November 2024. **MARES DOCUMENTATION MUST BE** sent to <u>vkelly@tattersalls.ie</u>

MARES IN FOAL

- **Passport***In accordance with Article 66 of Commission Delegated Regulation *DAFM
- Animal Health Certificate MUST be uploaded via your <u>online account</u> PRIOR to arrival at the Sales Complex (dated within 15 days of the Sale).
- Covering Certificate
- Pregnancy Certificate (dated within 21 days of the Sale)
- C.E.M. and EVA (dated within 30 days of the Sale)
- **EHV Vaccinations.** All pregnant mares are required to have been vaccinated against EHV in the 5th 7th & 9th month of pregnancy and the details recorded in the mare's passport. Any mare that does not have these vaccinations **will not be permitted** entry to the complex.

- Animal Health Certificate MUST be uploaded via your <u>online account</u> PRIOR to arrival at the Sales Complex (dated within 15 days of the Sale).
- Fillies Examination Certificate (dated within 14 days of the Sale)
- C.E.M. and EVA (dated within 30 days of the Sale)

BARREN BROODMARES

- **Passport***In accordance with Article 66 of Commission Delegated Regulation *DAFM
- Animal Health Certificate MUST be uploaded via your <u>online account</u> PRIOR to arrival at the Sales Complex (dated within 15 days of the Sale).
- **C.E.M. and EVA** (dated within 30 days of the Sale)
