Tattersalls Ireland Breeze Up Sale 2025

GENERAL INFORMATION

Arrival, Breeze Up and Sale Time

- The Sales Complex will be open for the arrival of 2 yr olds from **8am Tuesday the 20th May**. Please do not arrive before this time as you may not be permitted to enter the complex without prior arrangement.
- The **Practice Breeze** will start at **9am** on Wednesday the 21st May and finish at 2pm. Horses will be led or boxed from the complex to Fairyhouse Racecourse for the practice breeze. Horses will gather in groups of 20 in both pre-parade rings and make their way to the racecourse every 20 minutes under the supervision of Tattersalls Ireland staff.
- The **Breeze** will start at **8.30am** on Thursday 22nd May. A number of horses (larger drafts and pre-arranged) will make their way to the racecourse stables on the morning of the breeze. The remaining horses will be led or boxed from the complex to Fairyhouse Racecourse in groups of 20 under the supervision of Tattersalls Ireland staff
- **Sale** will commence at 10am on Friday 23rd May.

Number Clothes/Head Collar Tags

Number clothes must be collected from the CONTROL OFFICE. A second set of number clothes will be available for the actual breeze. **Vendors are required to use number cloths for the practice breeze also.** They **must be returned** to the control office following the Breeze. Please also return all head collar tags to the control office before leaving the premises.

VENDORS are requested to leave HEADCOLLARS on all sold lots.

Vendors Please Note:

- Animal Health Certificate - **MUST** be uploaded via your **online account** **PRIOR** to arrival at the Sales Complex - dated within 15 days of the Sale (From the 9th May)

SALES REQUIREMENTS

Please ensure you have all the following documentation before arriving at the Complex:

- **Passport**
- **Animal Health Certificate** – each cert **MUST** be uploaded via your **online account** **PRIOR** to arrival at the Sales Complex.
- **Flu Vaccinations (which do NOT need to be uploaded and will be checked by our vets during the ID checking process)** - Minimum requirement for all Lots is the primary course (consisting of 2 injections). Where vaccinations are found not to be up to date, a fee will be applied to the vendor's account.
- **All lots must** be registered on **DAFMs chip checker** system.

ONLY the **Animal Health Certificate** to be uploaded via your **online account** before Monday 19th May.
